

# WH Energy-Saving Electric Vehicle Charging Program



Wright-Hennepin (WH) offers an electric vehicle (EV) Energy-Saving Program that lets you charge your EV at a time convenient for you.

## How it works

- Energy rate varies based on time of day EV is being charged.
  - 5:00 a.m. - 5:00 p.m. @ \$0.12782 per kWh
  - 5:00 p.m. - 10:00 p.m. @ \$0.30154 per kWh
  - 10:00 p.m. - 5:00 a.m. @ \$0.06434 per kWh
- Charging is available 24/7.
- Energy rate is not subject to Power Cost Adjustment (PCA).
- May require a separate meter socket to be installed on the outside of home.
- The EV must be all-electric and have a minimum of 4.5kW charger rating to qualify.
- Requires the use of a hardwired, 240-volt, wall-mounted Level 2 charging station.

## How to enroll

1. Contact WH to discuss the program details.
2. Contact an electrician to receive a quote for the installation of your Level 2 charging station and metering equipment.
3. Complete required paperwork.
4. Schedule a time to pick up equipment.
5. Install charging station & metering equipment.
6. Complete state electrical inspection within 30 days of installation.
7. Notify WH that installation is complete. WH will do an ESP inspection. Rates and rebates will not be applied until the final inspection is complete.

## 2024 REBATES AVAILABLE

**Energy-Saving Program rebate: \$500**

Enrollment in an electric vehicle charging program is required to receive a rebate.

Rebates are available on new installations only. Rebates will be given as a credit on your account.

Rebates are paid on a first-come, first-served basis. Terms and conditions are subject to change.

Please allow six to eight weeks for rebate processing after ESP installation.

A state electrical inspection must be completed within 30 days of the metering equipment installation.
