## **Terms of the WH Energy-Saving Rebate Program**

- Rebate amount is \$5/kW for qualifying Dual Fuel Program participation. Minimum of 4.5 kW load connection required, maximum 50 kW per system.
- Rebates will be issued as a credit on your WH electric bill.
- The Dual Fuel equipment must be installed within WH's service territory.
- The Dual Fuel heating system will be on the metered Dual Fuel Energy-Saving Program (ESP).
- The ESP meter and receiver equipment will need to be located outside the home.
- Portable heaters, wood burning stoves and electric space heaters DO NOT qualify as a backup heat source.
- If electricity is your primary source of heating your home, you are eligible to receive a sales tax exemption. Forms can be found at whe.org.





### Terms of the WH Energy-Saving Rebate Program, continued

- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- Rebate dollars are limited and will be paid on a first-come, first-served basis.
- Fill out this form completely. Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing after ESP installation.
- Equipment must be purchased between January December 31, 2024. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:

Rebates are available only for members participating in the Dual Fuel Program on or after January 1, 2024. The program must be installed where electricity is supplied by WH.
