## **Terms of the WH Energy-Saving Rebate Program**

- Rebate amount is \$5/kW for qualifying ETS Home Heating Program participation. Minimum of 4.5 kW load connection required, maximum 50 kW per system.
- Rebates will be issued as a credit on your WH electric bill.
- ETS heating equipment must be installed within WH's service territory.
- The heat storage system will be on the metered Heat Storage Energy-Saving Program (ESP).
- The ESP meter and receiver equipment will need to be located outside the home.
- If electricity is your primary source of heating your home, you are eligible to receive a sales tax exemption. Forms can be found at whe.org.
- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.

- Rebate dollars are limited and will be paid on a first-come, first-served basis.

- Equipment must be purchased between January December 31, 2024. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:
