Terms of Residential Conservation Improvement Rebate Program

- This form is valid for the purchase/installation of either a bring your own charging station or a ZEF Energy charging station.
- Rebate amount is up to \$500 toward the purchase/installation of a hardwired, 240-volt, Level 2 wall-mount charging station.
- EV charging station will be required to be on an EV charging Energy-Saving Program through Wright-Hennepin (WH).
- The EV is required to be a battery electric vehicle (BEV) with a minimum of 4.5 kW charger rating. Plug in hybrid vehicles (PHEVs) do not qualify.
- The EV is required to be fully electric with a minimum of 4.5 kW charger rating.
- The EV charging station must be installed within WH’s electric service territory at an address that receives electricity from WH.
- One EV program rebate per household for life.

RESIDENTIAL CONSERVATION IMPROVEMENT PROGRAM

- Using additional outlets that are not connected to an ESP for charging the EV is prohibited.
- If bringing your own charging station, the ESP meter and receiver equipment must be located outside of the home.
- If installing a ZEF Energy charging station the meter and receiver equipment are integrated into the charging station.
- Member will pay the cost and arrange installation for all special equipment and/or additional switching mechanism necessary to meter the charging station.
- Fill out this form completely. Incomplete forms will be returned.
- Rebate dollars are limited and will be paid on a first-come, first-served basis.
- Rebates will be issued as a credit on your WH electric bill.
- **The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.**
- Please allow six to eight weeks for rebate processing after ESP installation.
- **Equipment must be purchased between January - December 31, 2024.** Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:

Rebates are available for Level 2 hardwired, 240-volt, wall mounted EV charging stations purchased on or after January 1, 2024. The charging station must be installed where electricity is supplied by Wright-Hennepin (WH) and controlled on an ESP. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program. Call WH at (763) 477-3000 to verify rebate program status.
