Terms of Residential Conservation Improvement Rebate Program:

- Rebate amount is \$300 for qualifying Metered Water Heating Program for 100-gallon water heater and mixing valve.
- Rebate will be issued as a credit on your Wright-Hennepin (WH) account.
- Water heaters must be installed within WH's service territory.
- Water heaters must be enrolled in WH's Metered Water Heating Energy-Saving Program (ESP).
- Hot Water Recirculation units (gravity or pumped) are not recommended to be used with the water heating programs.
- The ESP meter and receiver equipment will need to be located outside the home.
- **The program will be required to be in place for a minimum of five years.** If removed, the rebate will be prorated and billed to your electric account.
- **Rebate dollars are limited and will be paid on a first-come, first-served basis.**
- **Fill out this form completely. Incomplete forms will be returned**
- **Please allow six to eight weeks for rebate processing after ESP installation.**
- **Contact WH at (763) 477-3000 for final ESP inspection.** ESP rates and rebates will not be applied until final inspection is completed.
- **Equipment must be purchased between January - December 31, 2024.** Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:
