## Terms of Residential ECO Program

- Rebate amount is \$50 per qualifying ECM. Maximum rebate on (2) qualifying ECMs.
- Rebates will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- ECM must be installed within WH's service territory.
- Rebates are available to residential members who install HVAC equipment with an ECM.
- ECM rebate applies only on replacement or retrofit. New construction is not eligible.
- Rebate dollars are limited and will be paid on a first-come, first-served basis.
- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing.
- Equipment must be purchased between January 1 - December 31, 2025. Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to:

## Terms, continued

Rebates are available for the purchase of retrofit furnaces with a new ECM, or replacement ECMs purchased on or after January 1, 2025. Rebate dollars are limited and will be paid on a first-come, first-served basis. The ECM must be installed where electricity is supplied by Wright-Hennepin (WH). Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by HVAC contractor or vendor. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program.
