### Terms of Residential ECO Program

- Rebate amount is \$300 for qualifying Metered Water Heating Program for 100-gallon water heater and mixing valve.
- Rebate will be issued as a credit on your Wright-Hennepin (WH) account.
- Water heaters must be installed within WH's service territory.
- Water heaters must be enrolled in WH's Metered Water Heating Energy-Saving Program (ESP).
- Hot Water Recirculation units (gravity or pumped) are not recommended to be used with the water heating programs.
- Humidifiers need to be plumbed into a cold water source.
- The ESP meter and receiver equipment will need to be located outside the home.
- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing after ESP installation.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.

## Terms, continued

- Equipment must be purchased between January 1 - December 31, 2025. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:

Rebates are available only for members participating in the Metered Water Heating Program on or after January 1, 2025. Rebate dollars are limited and will be paid on a first-come, first-served basis. The program must be installed where electricity is supplied by WH. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program.
