#### Terms of WH rebate program

- The rebate amount for an air source heat pump (ASHP) is \$150 per ton, up to a maximum of \$675 (4.5 tons).
- Member agrees to allow Wright-Hennepin (WH) to manage the ASHP on days of high electrical demand, high wholesale energy prices and system emergencies.
  - Member agrees to allow WH to cycle ASHP up to 200 hours per cooling season. WH will cycle your ASHP on and off during this time.
  - Member agrees to allow WH control to cycle ASHP for up to 12 hours at a time per heating season, for a total of no more than 400 hours. During this time, the backup heating source is used.
- Rebates will be issued as credit on your WH electric bill.
- ASHP unit must be installed within WH's service territory.

# WH Energy-Saving Rebate Program

## Terms, continued

- ASHP unit will be on the Quick Cash ASHP Energy-Saving Program (ESP).
- ASHP unit will be metered at the general service rate.
- Members with an ASHP receive a credit of \$5 applied to their electric account for the months June through November. The member must have a minimum general service usage of 200 kWh per month to qualify for the credit.
- WH will provide installation of the load control device (receiver). WH will only pay for the standard installation of the load control device for the Quick Cash ASHP ESP.
- Member is responsible for ASHP unit installation cost and maintenance of the ASHP unit.
- Members must verify with their contractor that the newly installed ASHP system is compatible with the WH Energy-Saving demand management system equipment and control strategy to ensure no forfeiture of their manufacturer's warranty.
- The ESP receiver equipment will need to be located outside the home.
- Please allow six to eight weeks for rebate processing after ESP installation.
- The ESP for the ASHP unit will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- By applying for the rebate, you agree to the terms of the program.
- Rebate does not apply to ductless systems.
- Form must be filled out completely. **The form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Must be purchased between January 1 - December 31, 2025. Submit the completed rebate form and a copy of the original sales receipt within 90 days of purchase to:

Rebates are available only for the purchase of a new ASHP unit installed on or after January 1, 2025. Rebate dollars are limited and will be paid on a first-come, first-served basis. The ASHP must be installed where electricity is supplied by WH. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program. Call WH at (763) 477-3000 to verify rebate program status.
